## **ENLIST ®: #FREEDOMTOSPRAY SWEEPSTAKES**

OFFICIAL RULES

- 1. PROMOTION DESCRIPTION. **Enlist® #FreedomToSpray Sweepstakes** (the **"Sweepstakes"**) is open only to residents of the United States of America and begins 5/1/2023 at 12:00:00 AM (CT) and ends 7/30/2023 at11:59:59 PM (CT) ("Promotion Period").
