### How It Works

#### Start Clean

Start the season off right. Apply pre-emergence residual herbicides on your fields.

#### Plant

Plant corn hybrids containing the Enlist trait.

#### Purchase

Purchase qualifying crop protection products from an authorized retailer from October 1, 2018 to September 30, 2019 and apply at labeled rates.

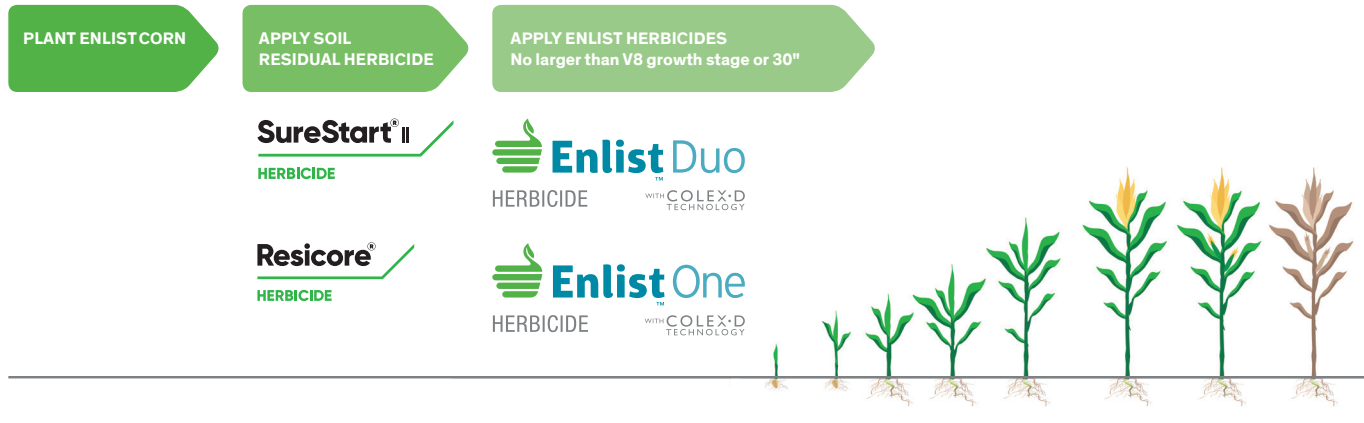

## Use Enlist™ herbicides as part of a program approach



For effective weed control in Enlist™ corn, use one of the recommended corn residual herbicides in this program, followed by a postemergence application of Enlist Duo® or Enlist One™ herbicides.



## Program Rules

### Grower Eligibility Criteria:

1. Purchase hybrids containing the Enlist corn trait from select seed brands.
2. Purchase one or more eligible crop protection products.

### Minimum Terms and Conditions for Rebate:

1. The rebate for an eligible grower or farm entity shall be calculated by:  
Multiplying the net corn units\* purchased by 2.5 acres per bag to determine the grower's eligible corn acres in the program.  
  
\*Net units shall equal corn bags purchased minus returns, replants, and/or promotional units.  
  
Match the grower's eligible crop protection products purchased against the grower's corn acres and the corresponding rebate earnings per acre.
2. Earnings under this program must reach or exceed **\$250** to qualify for a payment.
3. Eligible crop protection products will only be considered for rebate calculations if reported via electronic data exchange (EDI) or grower point of sale (GPOS) via Data Dimensions from crop protection manufacturers' authorized dealers and invoiced between October 1, 2018 and September 30, 2019. Dow AgroSciences reserves the right to refuse rebate payments on product that is not purchased directly from authorized dealers or retailers. Seed purchases must be invoiced between 9/1/18 and 8/31/19.
4. Rebate payment will only be made on final net units that are used on the grower's owned or rented acres.
5. Rebate payment will be in the form of a single-party check payable to the party named on the invoice.
6. Dow AgroSciences reserves the right to refuse rebate payments under this program if qualified grower receives payment for eligible crop protection product purchases under another program.
7. Dow AgroSciences reserve the right to modify or terminate the program at any time without notice to program participants.
8. Participation by growers in the program is voluntary and is not required in order to purchase any products participating in this program.
9. Qualifying Geography:  
Alabama, Arizona, Arkansas, Colorado, Delaware, Florida, Georgia, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maryland, Michigan, Minnesota, Mississippi, Missouri, Nebraska, New Jersey, New Mexico, New York, North Carolina, North Dakota, Ohio, Oklahoma, Pennsylvania, South Carolina, South Dakota, Tennessee, Texas, Virginia, West Virginia and Wisconsin.
10. Retailers must report EDI/POS by September 30, 2019 in order to be considered for this program.
